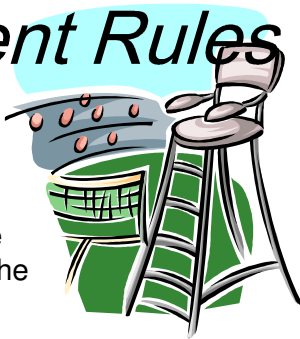


# Tournament Rules



- ⇒ Single elimination format.
- ⇒ Matches will not be rescheduled after the draw is made.
- ⇒ Players may enter 2 events.
- ⇒ Juniors 14 years and older are welcome in skill divisions. Juniors 13 and under may play in the junior divisions.
- ⇒ Players must be available to play within the tournament hours shown.
- ⇒ No-add scoring through the semi-finals, 2 out of 3 sets, 12 point tiebreaker at 6 all in each set.
- ⇒ **Entry fee must accompany entry form.** No refunds after the draw is available.
- ⇒ Trophies for 1st and 2nd place in all events over 4 entries, 1st place for round robins.

## SKILL LEVEL BREAKDOWNS:

OPEN - 4.6 and above

AA - 4.1 - 4.5

A - 3.6 - 4.0

B - 3.1 - 3.5

B - 2.6 - 3.0

C - 2.5 and under

Levels based on USTA ratings.

If your partner is a lower skill level than you, you must enter the higher division.

Mixed doubles is comprised of combining levels, and partners must be within one rating point. Example: 5.0 + 4.0 = 9.0.

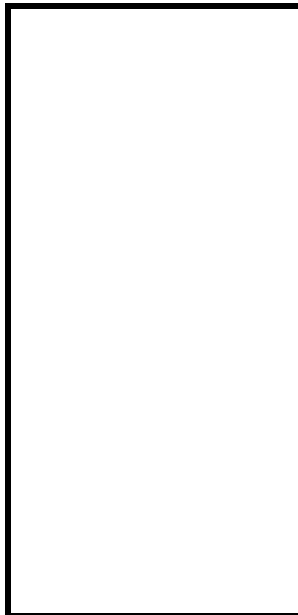
