

# Rules and Regulations

- Rules of the U.S.T.A shall govern play. Players are required to have a current U.S.T.A. card in their possession, or one may be obtained at the tournament desk.
- Each player is limited to 1 singles and 1 doubles event.
- Events must have a minimum of three entries. The size of the draw may be limited.
- All matches will be the best of three sets. At six games all the twelve-point tie-breaker will be in effect. No Ad scoring will be used through the quarterfinals.
- Tennis attire must be worn for all matches.
- Players may be defaulted after 15 minutes from match time.
- Warm-up is limited to ten minutes.
- Players may be asked to serve as linespersons.
- The point penalty system will be in effect. The tournament director reserves the right to reject any entry or default any player who refuses to cooperate with the tournament committee.
- Parents or coaches will not be allowed on the courts during matches.
- Consolation rounds will be played for singles only.
- Housing is not available.
- U.S.T.A. Junior Age Rules:
  - B-G 18's Player born July. 1, 1992 or later
  - B-G 16's Player born July. 1, 1994 or later
  - B-G 14's Player born July. 1, 1996 or later
  - B-G 12's Player born July. 1, 1998 or later
- Starting times will be available after 6PM on Monday, June 13th online at pnw.usta.com, or call the club at (253) 872-5545 (ext. 1).
- Refunds will not be granted once draws have been made.
- Trophies or plaques will be awarded to the winners and runners up of each age division.
- Entry fees must accompany entry form or name will not be placed in the draw.

Consolation matches may be played at an outdoor site.

**From Bellevue area:** Take 405 south to West Valley/Tukwila exit No. 1 (Hwy. 181). Go south on West Valley Hwy towards Kent for 3 miles. Turn right at 199th Pl. Turn left into parking lot.
