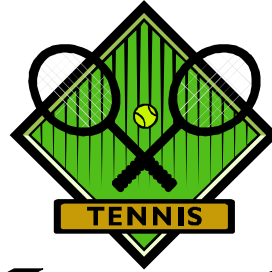
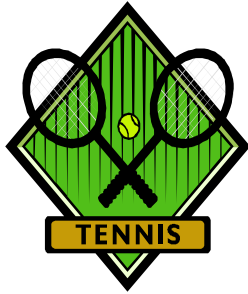


- ⇒ Players must be available to play within the tournament hours shown to the right.

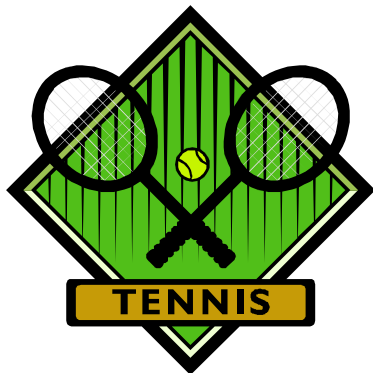
