**Senior Events (60+):** 4.0 & above, Mixed 7.0 & under  
**February 3<sup>rd</sup> – 5<sup>th</sup>:** 3.0, 4.0, 5.0 and Mixed 5.0, 7.0, 9.0  
**Senior Events (60+):** 3.5 & under, Mixed 8.0 and above

**ELIGIBILITY**

Tournament is open only to active BETC members. **Entry fee is \$44.00 per team.**  
 Entry fees must accompany all entries.

**FORMAT**

The tournament will be held over two separate weekends. Players may enter up to two events per weekend. All events are "First Match Consolation" format unless posted otherwise. Please note: Players **must** be available to play their scheduled main draw **AND** consolation match times.

**CHOOSING AN EVENT**

- Members must enter at the level of their USTA rating and/or club rating.
- Members without a USTA or club rating should contact Tournament Director Tracy Lockhart at Ext. 24.

(Note: Members may play up a division but not down). The tournament director has the option to place teams in events other than the one they sign-up for.

**DRAWS/CHECK-IN**

Players are responsible for finding out their time of play. **Draws will be posted at 6 PM on Tuesday, January 24 for the first weekend and at 6PM on Tuesday, January 31st for the second weekend.** Play will begin at 5 PM on Fridays and at 9:30 AM on Saturdays and Sundays. Players must check in 15 minutes prior to start time. Defaults will be made 15 minutes after scheduled start time. The tournament director has the option to combine any event with fewer than 3 entries. **Refunds will not be given after the draw is posted.**

**SCORING**

**Main draw matches:** No-ad scoring until the semi-finals, 2 out of 3 sets, with a 10-point super tiebreak for the 3<sup>rd</sup> set. Regular scoring in the semi-finals and finals with a 10- point super tiebreak for the 3<sup>rd</sup> set. **Consolation matches:** No-ad scoring with a 10-point super tiebreak for the 3<sup>rd</sup> set. One can of tennis balls per match.

**AWARDS**

Players will receive a commemorative BETC item for entering the tournament. All Club Champions will have their names placed on the BETC perpetual plaque.

**RELEASE OF DAMAGES**

The terms of this agreement will also serve as a release and indemnity agreement for my heirs, personal representative(s) and for all members of my family. I further state that I am eighteen (18) years of age or older and legally competent to sign this release that I understand these terms are contractual and not a mere recital, and that I have signed this document as my own free act. I understand that this Agreement waives important legal rights, and I acknowledge that I have fully informed myself of the contents of this Agreement by reading it before signing it.
