



## **Public - Tennis & Racquetball Associate Membership** **BETC is a non-profit, member-owned facility**

### **Eligibility**

Persons age 21 and older who are not affiliated with the Boeing Company with the approval of the Boeing Recreation Council.

### **Associate Membership Privileges**

- Membership includes immediate family (spouse and dependents as reported to the IRS) and same gender domestic partners.
- Pay court fees at the member rate. Make an unlimited amount of non prime-time and prime-time tennis and racquetball court reservations up to 8 days in advance.
- Participate in club activities. Participate in leagues on a space-available basis, however, first priority is to Share Members. Substitute into any league at no charge.
- Participate in USTA and Cup teams as a member.
- Participate in lesson programs at the member rate. Sign up for group or private lessons as far in advance as available.
- Applicants over the age of 70 receive a 20% reduction in dues.

### **How to Join**

Complete the application on back, select a payment option and provide your first payment. Please note the following payments included in your Tennis & Racquetball Associate Membership:

- \$425 Capital Fund Fee (Joining Fee), which may be paid upfront or over time and is non-refundable. Note: A \$70.00 administration fee is added to any capital fund not paid in full at time of application.
- Dues-\$139.16/quarter with quarterly billing.
- Quarterly payments are due the 1st of January, April, July and October. New applicants who have joined outside of the club's quarterly billing schedule will receive a bill for the prorated amount. After this payment, they will be on the regular quarterly schedule.
- Dues may be paid once per year, but billing is only available on a quarterly basis.

**Choose a payment option and complete the application below. A \$70 Administration Fee is added to any Capital Fund (Joining Fee) not paid in full at time of application.**

- Option 1 - Pay the capital fund (joining fee) in full and pay dues with quarterly billing.**  
With application, pay \$564.16 (\$425 capital fund + \$139.16 1st quarterly dues). Dues thereafter are \$139.16/quarter.
- Option 2 - Pay the capital fund (joining fee) over time and dues with quarterly billing.**  
With application, pay \$194.16 (\$55 1st Capital Fund contribution + \$139.16 1st quarterly dues) and then \$194.16 for 8 more quarters. Once the capital fund portion is paid in full, dues are \$139.16/quarter.
