Who can join BETC?

Share Membership—For Boeing employees, Boeing retirees, and any other personnel assigned to support the Company full time. Share Membership includes a refundable share deposit.

Associate Membership—For the general public (at times there may be a waiting list for this membership).

B-330 & A-930 Membership—A before 3:30 pm and after 9:30 pm “court reservation only” membership. Participation between 3:30 and 9:30 pm requires a guest fee. B-330 & A-930 members may not sign up for leagues or block times; however, they may sub in leagues or block times at any time for no charge.

Junior Affiliate Membership—Junior Affiliate Membership is for players under 21 years old, living at home.

Group Series Affiliate “Membership”—For non-members during any month they have signed up and paid for a lesson series.

USTA Membership—For individuals who play on one of BETC's USTA teams.

How much does membership cost?

Joining Fee (Capital Fund)—All members pay a non-refundable \$425 joining (capital fund) fee which is used towards club repairs and improvements. New members may either pay this fee in one lump sum or through quarterly payments for an additional administrative fee.

Dues—All members pay dues either monthly (Boeing payroll deduction), quarterly (retired Boeing employees, Associates and B-330/A-930 members), or semi-annually (Junior Affiliates). For more details, please take a look at the “Membership Application” enclosed with this letter.

Are there any other fees?

Court fees—\$12 for singles court and \$14 for doubles. Players who share a court divide the court fee.

Guest fees—Non-members pay \$12 each in addition to the court fee. Other guest fees apply to lessons.

Court Cards—Convenient pre-paid court fees.

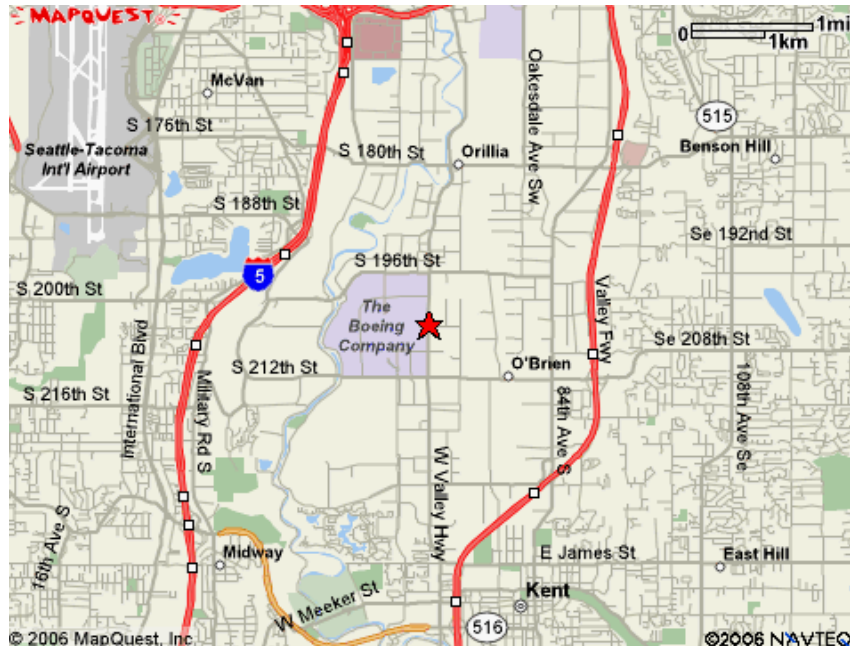
Other— There are fees for lessons, leagues, and other programs.

Directions to BETC:

The Boeing Employees Tennis Club is on Boeing property north of the star on the map. Access to the club is usually by I-5, I-405, Hwy 167 or Hwy 161 (West Valley Highway).

Directions to BETC:

From Seattle: Take I-5 south to I-405 Renton cutoff. Take I-405 and stay right. Take the West Valley Hwy/Tukwila exit (Hwy 181, exit #1). Go south towards Kent on West Valley Hwy for 3 miles. Turn right on 199th Place and enter on the east side of the building.

From Tacoma: Take I-5 north to 188th St. (Exit #152). Turn right at the bottom of the off ramp. Go down the hill into the valley. Turn left at 68th Avenue. Go about 1 mile north and turn left on 199th Place and enter on the east side of the building.

From Bellevue: Take I-405 south to exit #1 (Tukwila/West Valley, Hwy 181). Go south towards Kent on West Valley Hwy for 3 miles. Turn right on 199th Place and enter on the east side of the building.

From Puyallup: Take Highway 167 North to 212th St exit. Take a left off the exit heading west. Take a right on 68th Avenue. Go about 1 mile north and turn left on 199th Place and enter on the east side of the building.

From Kent East Hill: Go west on James/240th St. Take a right on Hwy 181 (West Valley Hwy). Take a left on 199th Place and enter on the east side of the building.

From Kent West Hill: Go east on Kent Des Moines Road. Follow down into the valley and take a left on Meeker Street. Take a left on Washington Avenue. Take a left on 199th Place and enter on the east side of the building.
