



Boeing - Racquetball & Handball Share Membership **BETC is a non-profit, member-owned facility**

Eligibility

Boeing employees/retirees and their spouses, domestic partners, and dependents as defined by Boeing benefit guidelines. Government, customer contract, and vendor personnel assigned full time to support Boeing, including their spouses and dependents, subject to approval by the Boeing Recreation Council and company badge required.

Share Membership Privileges

- Membership includes immediate family (spouse and dependents as reported to the IRS) and same-gender domestic partners.
- Pay court fees at the member rate.
- Make an unlimited amount of racquetball/handball court reservations up to 2 weeks in advance.
- Participate in club activities according to membership purchased. Substitute in leagues at no charge.
- Since BETC is a member-owned facility, share members can vote and participate in club affairs according to BETC Bylaws. Share members may also hold office in the BETC Board of Directors.
- Members over the age of 70 receive a 20% reduction in dues.

How to Join

Complete the application on back, select a payment option and provide your first payment. Please note the following payments included in your Racquetball & Handball Share Membership:

- A \$200 share deposit, which may be paid upfront or over time and is refundable upon written cancellation of membership.
- \$100 Capital Fund Fee (Joining Fee), which may be paid upfront or over time and is non-refundable. Note: A \$70.00 administration fee is added to any Capital Fund not paid in full at time of application.
- Dues—\$10.31/month with payroll deduction (separate Payroll Deduction form required) *or* \$30.93/quarter with quarterly billing.
- Quarterly payments are due the 1st of January, April, July and October. New applicants who have joined outside of the club's quarterly billing schedule will receive a bill for a prorated amount. After this payment, they will be on the regular quarterly billing schedule.
- Dues may be paid once per year, but billing is only available on a quarterly basis and payroll deduction is only available on a monthly basis.

Boeing - Racquetball & Handball Share Membership Application

Choose a payment option and complete the application below. A \$70 Administration Fee is added to any Capital Fund (Joining Fee) not paid in full at time of application.

Option 1 - Pay the share deposit and capital fund (joining fee) in full. Once the share deposit and capital fund portions are paid in full, dues are \$10.30/month or \$30.93/quarter.

Pay quarterly with quarterly billing:

With application, pay \$330.93 (\$200 share deposit + \$100 capital fund + \$30.93 1st quarterly dues).
Once the share deposit and capital fund portions are paid in full, dues are \$30.93/quarter.

Pay monthly with payroll deduction - *Separate "Payroll Deduction" form required:*

With application, pay \$300 (\$200 share deposit + \$100 capital fund) and fill out a *separate* "Payroll Deduction" form for \$10.31/month dues. Once the share deposit and capital fund portions are paid in full, dues are \$10.30/month.

Option 2 - Pay the share deposit, capital fund, and dues through payroll deduction. Once the share deposit and capital fund portions are paid in full, dues are \$10.31/month.

Pay monthly with payroll deduction - *Separate "Payroll Deduction" form required:*

Make no payment at time of application. Fill out a *separate* "Payroll Deduction" form for \$110.31/month (\$66.67 share deposit + \$33.34 capital fund + \$10.31 monthly dues) for 3 months.
Once the share deposit and capital fund are paid in full, dues are \$10.31/month.
