### **Eligibility**

Anyone over the age of 21 with the approval of the Boeing Recreation Council. Available Memorial Day to Labor Day.

### **Summer Membership Privileges**

- Membership includes immediate family (spouse and dependents as reported to the IRS) and same gender domestic partners.
- Pay court fees at the member rate.
- Make reservations for tennis, racquetball, or handball courts 5 days in advance.
- Participate in club activities on a space-available basis, however, first priority is to Share and then to Associate Members. Substitute into any league at no charge.
- Participate in USTA and Cup teams as a member.
- Participate in lesson programs at the member rate. Sign-up for group or private lessons as far in advance as available.
- Applicants over the age of 70 receive a 20% reduction in dues.

### **How to Join:**

Complete the application on back and submit your payment of \$172.40. Please note the following amounts included in your Summer Membership:

- \$64.16 for the Capital Fund Fee (Joining Fee) which is non-refundable. An active Capital Fund Fee is transferable to another type of membership, with a \$50 transfer fee.
- Dues - \$108.24 dues
- After July 15th the fee is cut in half and the total payment is \$86.20 (\$32.08 capital fund + \$54.12 dues).
