Eligibility

Individuals age 21 and older with the approval of the Boeing Recreation Council. Renewable quarterly membership. The USTA/Cup Tennis Membership is an individual, not a family membership.

USTA/Cup Membership Privileges

- Participate in but not make tennis reservations.
- Pay court fees at the member rate. Participate as a member in USTA and Cup matches at the member rate.
- Membership term is a 3 month period from date of application.
- Substitute into any league or block time at no charge, but not participate as a regular.
- Participate in, but not reserve, team workouts.
- Applicants over the age of 70 receive a 20% reduction in membership dues.

Complete the application below and submit your payment of \$106.38. Please note the following amounts included in your USTA/Cup Membership:

- \$60 for the Capital Fund Fee (Joining Fee) which is non-refundable. An active Capital Fund fee is transferable to another type of membership, with a \$50 transfer fee.
- Dues - \$46.38 for the three-month period.
